

PRIVACY STATEMENT

SECTION 1 - WHAT DO I DO WITH YOUR INFORMATION?

When you purchase something from me, as part of the buying and selling process, I collect the personal information you give me such as your name and email address.

When you browse this site, I also automatically receive your computer's internet protocol (IP) address in order to provide me with information that helps me to learn about your browser and operating system.

Email marketing: With your permission, I may send you emails about our services, new services and other updates.

SECTION 2 - CONSENT

How do you get my consent?

When you provide me with personal information to complete a transaction, I imply that you consent to me collecting it and using it for that specific reason only. This is typically done on a third party and Kristen Day and A Visual Business aren't responsible for what happens when you leave my site. That responsibility lies with that third party.

If I ask for your personal information for a secondary reason, like marketing, I will either ask you directly for your expressed consent, or provide you with an opportunity to say no.

How do I withdraw my consent?

SECTION 3 - DISCLOSURE

I may disclose your personal information if I am required by law to do so or if you violate our Terms of Service.

SECTION 4 - THIRD-PARTY SERVICES

In general, the third-party providers used by me will only collect, use and disclose your information to the extent necessary to allow them to perform the services they provide to us.

However, certain third-party service providers, such as payment gateways and other payment transaction processors, have their own privacy policies in respect to the information I am required to provide to them for your purchase-related transactions. Again, Kristen Day and A Visual Business aren't responsible for what happens when you leave my site. That responsibility lies with that third party.

For these providers, I recommend that you read their privacy policies so you can understand the manner in which your personal information will be handled by these providers.

However, my practice is to not collect or store any credit card information.
